

# **Implementation Regulations for Kainan University's Scholarships Encouraging Students to Obtain National Examinations and Professional Certifications**

Article 1: Kainan University (hereinafter referred to as the "University") establishes  
the "Implementation Regulations for Kainan University's Scholarships  
Encouraging Students to Obtain National Examinations and Professional

Certifications" (hereinafter referred to as the "Regulations") to encourage the University's students to study diligently, focus on their academic pursuits, and pass national examinations and acquire professional certifications.

Article 2: The certifications referred to in these Regulations are divided into the following three categories:

Category 1:

(1) Scholarships for National Examinations conducted by the government and relevant organizations.

(2) Eligibility: Students currently enrolled at the University and alumni who have graduated within one year and have passed the General Scholastic Ability Test (GSAT), Special Examinations, or other equivalent certification exams as recognized by the University may apply.

Category 2:

(1) Scholarships for Key Development Projects.

(2) Eligibility: Students currently enrolled in international language certification programs and certifications related to key development projects offered by colleges. Students who have graduated are not eligible to apply.

Category 3:

(1) Professional Certification Scholarships: Each college selects examination subjects (divided into Levels A and B) according to educational objectives, focusing on actively preparing students.

(2) Eligibility: Students currently enrolled in certifications relevant to their respective colleges. Graduates are not eligible to apply.

Article 3: Incentives (as shown in the attached table):

Category 1:

(1) Students who achieve Level 1 or an equivalent level in national examinations will receive a scholarship of NT\$100,000.

(2) Students who achieve Level 2 or an equivalent level in national examinations will receive a scholarship of NT\$50,000.

(3) Students who achieve Level 3 or an equivalent level in national examinations will receive a scholarship of NT\$30,000.

(4) Students who pass the General Civil Service Examinations or an equivalent level will receive a scholarship of NT\$10,000.

(5) Students who pass the Basic Civil Service Examinations or an

equivalent level will receive a scholarship of NT\$5,000.

(6) Certificates and licenses from other equivalent examinations will be determined by individual colleges and implemented after approval by the Administrative Meeting.

Category 2: Scholarships are awarded based on the type and level of certification, as specified in the Certification Level Differentiation Table.

Category 3: Level A awards cover 100% of registration fees, with a maximum limit of NT\$2,000; Level B awards cover 60% of registration fees, with a maximum limit of NT\$1,000.

Scholarships in Category 3 may be adjusted according to the budget for the current academic year.

#### Article 4: Application and Review Procedure:

Applicants should submit the relevant proof of certification (online application form, certificate or license, proof of registration fee payment) to their respective departments within the specified application period for each semester after obtaining the certification. Alumni who graduated within one year applying for Category 1 scholarships should also attach a copy of their graduation certificate.

After the initial review by departments, applications will be submitted to colleges. Colleges will convene college meetings to conduct reviews. Upon approval, applications will be forwarded to the University's Scholarships and Financial Aid Committee for final approval.

The University's Scholarships and Financial Aid Committee will review applicants' qualifications and related disbursement matters.

Article 5: In case of doubts regarding special certifications and level assessments, they will be reviewed by the Scholarships and Financial Aid Committee, and the appropriate procedures will be followed.

Article 6: These Regulations are approved by the Student Scholarships and Financial Aid Committee and the Administrative Meeting, and will be enforced after being approved by the University President. The same procedure applies to any amendments.
